No. 18'4'83-5 Lab. 1/2785.—In exercise of the powers conferred under rule 16 of the Punjab Payment of Un-employment Allowance to Educated Un-employed Persons Rules, 1978 the Governor of Punjab is pleased to make the following rules further to amend these rules namely :—

(i) These rules may be called "The Punjab Payment of Unemployment Allowance to Educated Un-employed Persons (Amendment) Rules, 2005.

(ii) These rules shall come into force with effect from 1st April, 2005.

2. In Rule 6 of the Punjab Payment of Un-employment Allowance to Educated Unemployed Persons. Rules 1978 (herein-after referred to as the said Rules) after the words "Un-employment allowance shall be payable to each educated un-employed applicants at the following rates" the following shall be inserted :—

I For Blind, Deaf and Dumb Persons. (If he/she) furnishes a medical certificate from Medical Officer of Government Hospital/Dispensary to that effect and is of Punjab Origin :—

(a) For Matriculate/Under Graduate applicants .. Rs. 450 Per Month

(b) For Graduate/Post Graduate applicants .. Rs. 600 Per Month

II For Ortho-peadically Handicapped Persons :—

(a) For Matriculate/Under Graduate applicants .. Rs. 225 Per Month

❖ **Name of Programmes**

"The Punjab Payment of Unemployment Allowance to Educated Unemployed Persons Rules 1978"

❖ **Objective**

To give some financial help (solace) to those who are registered with any of the employment exchanges of Punjab for more than three years and have not been able to get any assistance.

❖ **Criteria for the eligibility**

- I. Must be domicile of Punjab.
- II. Must be registered with the Employment Exchange for at least 3 Years (Physically handicapped become eligible after one year of registration and deaf and dumb and blind from the time of registration)
- III. Should be in the age group of 17 to 40 years.
- IV. Should neither be a regular student nor having any income of his own.
- V. Should not have more than Rs. 12000/- annually as family income.
- VI. Must apply for allowance within a specified period.
- VII. Can avail this benefit for total 3 Years.

❖ **Pre-requisites**

The eligible candidate has to bring his registration card along with the following forms filled in original and in attested form.
